

1 [Consolidation of Special Statewide Election and special Community College District election  
2 with the Consolidated Municipal Election scheduled for November 8, 2005.]

3 **Resolution consolidating the Special Statewide Election and special Community**  
4 **College District election, to be held in the City and County of San Francisco on**  
5 **November 8, 2005, with the Consolidated Municipal Election to be held in the City and**  
6 **County of San Francisco on the same date, and providing that the election precincts,**  
7 **voting places and officers for the Special Statewide Election and special Community**  
8 **College District election shall be the same as for the Consolidated Municipal Election.**

9 WHEREAS, A General Municipal Election is scheduled to be held in the City and  
10 County of San Francisco on November 8, 2005 for the purpose of voting on candidates for  
11 local office and proposed local ballot measures to be submitted to the voters; and

12 WHEREAS, The Board of Supervisors called a special election to be held in the City  
13 and County of San Francisco on November 8, 2005 for the purpose of voting on a proposed  
14 general obligation bond measure, and consolidated the special municipal bond measure  
15 election with the General Municipal Election scheduled for the same date; and

16 WHEREAS, The Governor of the State of California called a Special Statewide Election  
17 to be held on November 8, 2005; and

18 WHEREAS, The Board of Trustees of the San Francisco Community College District  
19 called a special election to be held in the City and County of San Francisco on November 8,  
20 2005 for the purpose of voting on a proposed general obligation bond measure, and  
21 requested that the special bond measure election be consolidated with other elections  
22 scheduled for the same date; and

23 WHEREAS, The Board of Supervisors believes that it is in the best interests of the  
24 public that the Special Statewide Election and special Community College District election be

1 consolidated with the General Municipal Election and special municipal bond measure  
2 election, as authorized by law; now, therefore, be it

3           RESOLVED, That pursuant to Elections Code section 10400 et seq., the Special  
4 Statewide Election and special Community College District election to be held in the City and  
5 County of San Francisco on November 8, 2005 shall be and hereby are consolidated with the  
6 Consolidated Municipal Election scheduled for the same date; and, be it

7           FURTHER RESOLVED, That the voting precincts, polling places, and officers of the  
8 Special Statewide Election and special Community College District election shall, in every  
9 case, be the same; that there shall be only one set of election officers in each precinct, to wit,  
10 the election officers to be appointed by the Director of Elections for each precinct; that all  
11 candidates, ballot measures and bond proposals shall be set forth on the ballots provided for  
12 said election; that the elections shall be held in all respects as though there were only one  
13 election, and that all returns shall be canvassed by the Director of Elections as provided in the  
14 California Elections Code.




