14 disasters; and,

15 WHEREAS, The State of California, through its renamed State Homeland Security
16 Grant Program, provides support for the development and maintenance of the capability of
17 local jurisdictions to prepare for and respond to terrorist attacks using weapons of mass
18 destruction and provides for the dispersal of federal funds provided for this purpose under
19 Public law 107-206; and,

20 WHEREAS, The City and County of San Francisco has participated in these programs
21 since their inception and deems participation in these programs as vital to the continued well
22 being of its citizens; and,


23 WHEREAS, The State of California requires that applicant's agents be named in the

5 and County of San Francisco to execute for and on behalf of the City and County of San
6 Francisco, a public entity established under the laws of the State of California, any
7 applications, assurances, and documents necessary for the purpose of obtaining federal and
8 state financial assistance under the Emergency Management Performance Grant Program,
9 the renamed State Homeland Security Grant Program, Public Law 107-206 and any other
10 federal funding programs that are passed through the State of California.




