8 WHEREAS, Leland Avenue between Bayshore Boulevard and Rutland Street is the
9 neighborhood commercial center for the Visitacion Valley neighborhood, located in the
10 southeastern portion of San Francisco, and is an economically struggling commercial district,
11 with many vacant storefronts and an undistinguished and cluttered visual environment; and,

12 WHEREAS, Leland Avenue has been the full or partial subject of past planning efforts,
13 including the Schlage Lock/Visitacion Valley Strategic Concept Plan, and the Leland/Bayshore
14 Commercial District Revitalization process, and has been included within the boundaries of
15 the Visitacion Valley Redevelopment Survey Area; and,

16 WHEREAS, The Friends of City Planning received \$75,000 in support of the Leland
17 Avenue Revitalization Project from the Evelyn and Walter Haas, Jr. Fund; and,

18 WHEREAS, The Planning Department applied for and received a \$75,000 grant from
19 the Friends of City Planning to support the streetscape design efforts of the Leland Avenue
20 Revitalization Project; and,

21 WHEREAS, The San Francisco Planning Department will engage in a process to help
22 design streetscape improvements to Leland Avenue with the goal of enhancing the street's
23 aesthetic appeal and revitalizing its commercial businesses; and will work in collaboration with
24 the Department of Public Works on the Leland Avenue Revitalization Project; and,




