3 **Resolution authorizing the Director of Public Works to execute amendment to the**
4 **Design Agreement for the Laguna Honda Hospital Replacement Program modifying the**
5 **total contract amount from \$32,595,782 to \$33,706,892.**

7 WHEREAS, The City and County of San Francisco, through its Director of Public
8 Works, has entered into an agreement dated November 30, 2000 with Anshen+Allen/Gordon
9 H. Chong & Partners, a Joint Venture, for the design of the Laguna Honda Hospital
10 Replacement Program; and,

11 WHEREAS, By Resolution 994-01, approved December 28, 2001, the Board of
12 Supervisors authorized the Director to amend the November 30, 2000 agreement to increase
13 the total contract amount to an amount not to exceed \$29,900,000, and,

14 WHEREAS, By Resolution 579-03, approved September 5, 2003, the Board of
15 Supervisors authorized the Director to amend the November 30, 2000 agreement to increase
16 the total contract amount to an amount not to exceed \$31,533,540; and,

17 WHEREAS, By Resolution 561-04, approved September 30, 2004, the Board of
18 Supervisors authorized the Director to amend the November 30, 2000 agreement to increase
19 the total contract amount to an amount not to exceed \$32,595,782; and,

20 WHEREAS, the Director intends to increase the scope of services under the
21 agreement with Anshen+Allen/Gordon H. Chong & Partners, a Joint Venture, and to increase
22 the total contract amount under the agreement to an amount not to exceed \$33,706,892; and,


23 WHEREAS, Section 9.118(b) of the Charter requires that all agreements in excess of
24 ten million dollars or amendments to such agreements in excess of \$500,000 be approved by


