3 **Resolution appointing Gina Fromer, Ellen Stroud, Daisy Anarchy and Gail Priestley,**  
4 **terms indefinite, to the Food Security Task Force, residency requirement waived.**

6 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
7 does hereby appoint the hereinafter designated persons to serve as members of the Food  
8 Security Task Force, pursuant to the provisions of Ordinance No. 206-05, for the term  
9 specified:

10 Gina Fromer (residency requirement waived), new appointment, seat 1, must be a  
11 representative of a community-based organization that provides nutritional support and  
12 increases the food security of San Francisco residents, for an indefinite term.

13 Ellen Stroud, new appointment, seat 2, must be a representative of a community-based  
14 organization that provides nutritional support and increases the food security of San Francisco  
15 residents, for an indefinite term.

16 Daisy Anarchy, new appointment, seat 3, must be a representative of a community-  
17 based organization that provides nutritional support and increases the food security of San  
18 Francisco residents, for an indefinite term.

19 Gail Priestley (residency requirement waived), new appointment, seat 4, must be a  
20 representative of a community-based organization that provides nutritional support and  
21 increases the food security of San Francisco residents, for an indefinite term; and, be it

22 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 23 1. The membership of the Food Security Task Force has a goal to be representative of  
24 the diversity of the City and County of San Francisco.

- 1           2. Applicants Gina Fromer and Gail Priestley, new appointees, who are not residents  
2           of San Francisco, are persons with experience that uniquely qualifies them to serve  
3           on the Food Security Task Force.
- 4           3. The Food Security Task Force has attempted to fill the positions, for which Gina  
5           Fromer and Gail Priestley were nominated, with an individual who is a City resident  
6           and who have the specific experience, skills, and qualifications, but has been  
7           unable to do so at this time. The Rules Committee has certified that Gina Fromer  
8           and Gail Priestley are qualified to serve on the Food Security Task Force.
- 9           4. After exercising due diligence, the Board of Supervisors concludes that there are no  
10          other possible representatives, who are residents of San Francisco and who have  
11          the specific experience, skills, or qualifications possessed by these applicants, and  
12          who are willing to serve on the Food Security Task Force at this time; and, be it

13          FURTHER RESOLVED, That the Board of Supervisors waives the residency  
14          requirement for Gina Fromer and Gail Priestley, as allowed in cases where no qualified City  
15          resident, willing to serve, can be found, pursuant to Section 4.101 of the City Charter that  
16          requires person(s) appointed to boards, commissions, and advisory bodies established by  
17          legislative act of the Board of Supervisors to be resident(s) of the City and County of San  
18          Francisco.


