

1 [Contract funds to participate in the traineeship for AIDS prevention studies at the University  
2 of California at San Francisco Center on AIDS Prevention.]

3 **Resolution authorizing the San Francisco Department of Public Health (SFDPH) to**  
4 **enter retroactively into an agreement with the University of California San Francisco,**  
5 **Center on AIDS Prevention Studies (UCSFCAPS) the primary contractor, and expend**  
6 **funds in the amount of \$6,624 in order to participate in the traineeship for AIDS**  
7 **prevention studies (TAPS) at UCSFCAPS for the two month period of July 1, 2005,**  
8 **through August 31, 2005.**

10 WHEREAS, UCSFCAPS is the recipient of a grant award from the National Institutes of  
11 Health (NIH) for a traineeship project; and,

12 WHEREAS, SFDPH and UCSFCAPS have agreed to enter into a subcontract  
13 agreement to participate in this project; and,

14 WHEREAS, UCSFCAPS has agreed to reimburse SFDPH in the amount of \$6,624  
15 under the terms of this subcontract agreement; and,

16 WHEREAS, As a condition of receiving these funds, UCSFCAPS requires SFDPH to  
17 enter into an agreement (the "Agreement"), a copy of which is on file with the Clerk of the  
18 Board of Supervisors in File No. 051507, which is hereby declared to be a part of  
19 this resolution as if set forth fully herein; and,

20 WHEREAS, The subcontract agreement budget includes provision for indirect costs of  
21 \$710; and,

22 WHEREAS, This Resolution requires expedited review by the Board of Supervisors  
23 because we did not receive the subcontract agreement until July 14, 2005; and,

24 WHEREAS, Resolutions authorizing the acceptance and expenditure of grant funds  
25 may be placed automatically on the consent agendas in committee, as they are usually


1 considered to be routine items, and this resolution authorizes the acceptance and expenditure  
2 of grant funding; now, therefore, be it

3 RESOLVED, That SFDPH is hereby authorized to enter retroactively into a subcontract  
4 agreement in the amount of \$6,624 with UCSFCAPS, the primary contractor; and, be it

5 FURTHER RESOLVED, That the Director of Health is authorized to enter into the  
6 agreement on behalf of the City; and, be it

7 FURTHER RESOLVED, That the Controller is directed to designate the position funded  
8 under this agreement as a "G" or grant-funded position which would terminate when the  
9 agreement expires.




