3 **Resolution authorizing the San Francisco Department of Public Health (SFDPH) to**  
4 **accept and expend retroactively a grant in the amount of \$1,488,000 from the**  
5 **Department of Health and Human Services, Centers for Medicare and Medicaid**  
6 **Services (DHHS,CMMS) to improve HIV/AIDS treatment and prevention services in San**  
7 **Francisco and to enter into an agreement for the use of these funds; for the period of**  
8 **July 1, 2005 to June 30, 2006.**

10 WHEREAS, SFDPH has been awarded a grant from DHHS,CMMS in the amount of  
11 \$1,488,000 to improve HIV/AIDS treatment and prevention services in San Francisco; and,

12 WHEREAS, As a condition of receiving the grant funds, DHHS,CMMS requires the City  
13 to enter into an agreement (the "Agreement"), a copy of which is on file with the Clerk of the  
14 Board of Supervisors in File No. 051506, which is hereby declared to be a part of  
15 this resolution as if set forth fully herein; and,

16 WHEREAS, The grant budget includes provision for indirect costs of \$19,337; now,  
17 therefore, be it


18 RESOLVED, That SFDPH is hereby authorized to accept and expend retroactively a  
19 grant in the amount of \$1,488,000 from DHHS,CMMS; and, be it

20 FURTHER RESOLVED, That SFDPH is hereby authorized to accept and expend the  
21 grant funds in accordance with the requirements set forth in the Agreement pursuant to San  
22 Francisco Administrative Code section 10-170-1; and, be it

23 FURTHER RESOLVED, That the Director of Health is authorized to enter into the  
24 agreement on behalf of the City; and, be it


1           FURTHER RESOLVED, That the Controller is directed to designate the positions  
2 funded under this agreement as "G" or grant-funded positions which would terminate when  
3 the agreement expires.


