9 WHEREAS, Eclectic Cup, LLC is seeking issuance of a Type 42 on-sale beer  
10 and wine public premises license for Que Syrah, located at 230 West Portal Ave.; and,

11 WHEREAS, The City Planning Department has verified that the area is properly  
12 zoned; and

13 WHEREAS, The Police Department recommends that the liquor license  
14 application be approved with conditions; now, therefore, be it

15 **RESOLVED**, That in accordance with Section 23958.4 of the California Business  
16 and Professions Code, the Board of Supervisors of the City and County of San  
17 Francisco hereby determines for the foregoing reasons that the issuance of a Type 42  
18 on-sale beer and wine public premises license, to Eclectic Cup, LLC for Que Syrah,  
19 located at 230 West Portal Ave. will serve the public convenience and necessity of the  
20 people of the City and County of San Francisco.

21 Conditions: (1) No noise shall be audible beyond the area under control of the  
22 licensee; (2) Petitioners shall not permit their patrons or the general public to loiter or  
23 congregate on the sidewalks adjacent to the licensed premises; (3) The petitioner(s)  
24 shall be responsible for maintaining free of litter the area adjacent to the premises over  
25 which they have control; (4) Sales and service of alcoholic beverages shall be permitted

1 only between the hours of 12:00 noon to 10:00 p.m. Sunday through Thursday, 3:00  
2 p.m. to 11:00 p.m. Friday and Saturday.




