3 **Resolution determining that the transfer of a Type 48 on-sale general public**
4 **premises license from 303 Filbert Street to 85 Campton Place to RHS Partners,**
5 **LLC for 85 Campton Place will serve the public convenience and necessity of the**
6 **people of the City and County of San Francisco, in accordance with Section**
7 **23958.4 of the California Business and Professions Code, with conditions.**

9 WHEREAS, RHS Partners, LLC is seeking transfer of a Type 48 on sale general
10 public premises license for 85 Campton Place located at 85 Campton Place; and,

11 WHEREAS, The City Planning Department has verified that the area is properly
12 zoned; and,

13 WHEREAS, The Police Department recommends that the liquor license
14 application be approved with conditions; now, therefore, be it

15 RESOLVED, That in accordance with Section 23958.4 of the California Business
16 and Professions Code, the Board of Supervisors of the City and County of San
17 Francisco hereby determines for the foregoing reasons that the transfer of a Type 48
18 on-sale general public premises license from 303 Filbert Street to 85 Campton Place for
19 RHS Partners, LLC for 85 Campton Place, will serve the public convenience and
20 necessity of the people of the City and County of San Francisco.

21 Conditions: (1) No noise shall be audible beyond the area under control of the
22 licensee; (2) Petitioners shall not permit their patrons or the general public to loiter or
23 congregate on the sidewalks adjacent to the licensed premises; (3) The petitioner(s)
24 shall be responsible for maintaining free of litter the area adjacent to the premises over
25 which they have control; (4) Sales and service of alcoholic beverages shall be permitted

1 only between the hours of 12:00 noon to 2:00 a.m. daily (5) Sales and service of
2 alcoholic beverages for consumption off the premises are strictly prohibited; (6)
3 Petitioners shall provide at lease two (2), readily identifiable, security personnel during
4 hours of entertainment and shall maintain order within the premises as well as outer
5 areas adjacent to the premises over which petitioners has control and prevent any
6 activity which would interfere with the quiet enjoyment of the property by nearby
7 residents. Said security shall remain at the premises one (1) hour after closing to insure
8 the quiet, safe and orderly departure of patrons.




