

1 [Street Improvements on 25<sup>th</sup> Avenue]

3 **Resolution requesting that the Municipal Transportation Agency and Department of**  
4 **Public Works, work with the 25th Avenue Neighborhood Association to address,**  
5 **improve, and enhance conditions on 25th Avenue, and to expend funds as feasible and**  
6 **necessary to meet those ends.**

8 WHEREAS, 25th Avenue between Fulton and El Camino Del Mar is a major route in  
9 San Francisco linking impressive recreational resources—Golden Gate Park with our coastal  
10 resources: The Presidio, Baker Beach, China Beach, Land's End, and the Palace of the  
11 Legion of Honor; and,

12  
13 WHEREAS, 25th Avenue is primarily (97%) a residential street with two schools for  
14 young children, two playgrounds, a synagogue, and a Chinese Community Center; and,

15 WHEREAS, 25th Avenue is presently a 4-lane street and since being designated a  
16 secondary arterial in the mid-1960's has been used like an expressway and an alternate  
17 route (from Park Presidio) to and from the Golden Gate Bridge and 19th Avenue; and,

19 WHEREAS, 25th Avenue is bearing the burden of steadily increasing auto and truck  
20 traffic and its concomitant noise and air pollution, wear and tear on the street, and actual  
21 shaking of homes; and,

22 WHEREAS, 25th Avenue has been the site of numerous automobile accidents  
23 and is often beset with traffic moving at 40-45 miles per hour, and occasionally cars traveling  
24 at 50 miles per hour; and,

1           WHEREAS, The 25th Avenue Neighborhood Association is comprised of and  
2 open to any and all residents of 25th Avenue between Fulton and El Camino Del Mar; and,  
3 now, therefore, be it

4           RESOLVED, That the San Francisco Board of Supervisors does hereby request that  
5 The Municipal Transportation Agency and the Department of Public Works institute measures  
6 for safety, traffic calming, bicycle lanes and greening enhancement.

8           FURTHER RESOLVED, That the Municipal Transportation Agency and Department of  
9 Public Works, work with the 25th Avenue Neighborhood Association to address, improve, and  
10 enhance conditions on 25th Avenue.


