3 **Resolution authorizing the Director of Public Health and the Director of the Office of**  
4 **Contract Administration/Purchaser to continue a contract between the City and County**  
5 **of San Francisco and Accordis, Inc. to provide retroactive claiming of aged accounts**  
6 **services for the period of July 1, 2004 through June 30, 2008.**

8 WHEREAS, The Department of Public Health desires to continue to capture revenue  
9 through the retroactive claiming of aged accounts from Medi-Cal pending, Pharmacy  
10 Outpatient accounts, self-pay sources and other Government Payer and Non-Government  
11 payer sources through a contract with Accordis, Inc., which assists in the identification and  
12 billing of accounts eligible for retroactive recovery, when available sources were not  
13 previously identified by the Department; and,

15 WHEREAS, The revenue collected by said contract will exceed one million dollars  
16 (\$1,000,000); and,


17 WHEREAS, Section 9.118 of the San Francisco Charter requires that such contracts  
18 be approved by the Board of Supervisors; now, therefore, be it

19 RESOLVED, That the Board of Supervisors hereby authorizes the Director of Public  
20 Health and the Director of the Office of Contract Administration/Purchaser, on behalf of the  
21 City and County of San Francisco, to continue a contract with Accordis, Inc. for the period July  
22 1, 2004 through June 30, 2008 to provide retroactive claiming of aged accounts services; and,


