3 **Resolution approving the acceptance of a monetary gift of \$53,075 from Michael Lanza**
4 **to the Recreation and Park Department to fund improvements for the Arkansas**
5 **Friendship Community Garden and a pathway at Potrero Hill Playground, and to**
6 **support recreational programs at Potrero Hill Recreation Center.**

8 WHEREAS, The City and County of San Francisco (the "City") vacated 22nd Street
9 between Arkansas and Connecticut Streets per Ordinance No. 171-05, which is occupied in
10 part by the Arkansas Friendship Community Garden; and

11 WHEREAS, City has instructed the purchase and sale of real property in the City and
12 County of San Francisco known as a portion of vacated 22nd Street per Ordinance No. 171-05
13 by and between City and Michael Lanza; and,

14 WHEREAS, the Arkansas Friendship Community Garden, managed by the Recreation
15 and Park Department for the Department of Public Works, will be impacted by the
16 aforementioned sale; and,

17 WHEREAS, Potrero Hill Playground and Recreation Center, under the jurisdiction of
18 the Recreation and Park Department, are located adjacent to Arkansas Friendship
19 Community Garden; and,

20 WHEREAS, the community has requested pathway improvements at Potrero Hill
21 Playground, while Potrero Hill Recreation Center provides invaluable recreational programs to
22 the community; and,

23 WHEREAS, Michael Lanza wishes to donate \$53,075 to City for improvements to
24 Arkansas Friendship Community Garden and a pathway at Potrero Hill Playground, and to
25 support recreational programs at Potrero Hill Recreation Center; now, therefore, be it

1 RESOLVED, That the San Francisco Board of Supervisors hereby authorizes the
2 Recreation and Park Department to accept a monetary gift of \$53,075 from Michael Lanza for
3 improvements to the Arkansas Friendship Community Garden and a pathway at Potrero Hill
4 Playgrounds, and to support recreational programs at Potrero Hill Recreation Center.


