3 **Resolution appointing Susan Stryker and Philip Choy, terms ending December 16, 2005**  
4 **and Charles Striplen, term ending April 21, 2006, to the San Francisco Museum and**  
5 **Historical Society Advisory Committee, residency requirement waived.**

7       RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
8 does hereby appoint the hereinafter designated persons to serve as members of the San  
9 Francisco Museum and Historical Society Advisory Committee, pursuant to the provisions of  
10 the Administrative Code Article VIII, Section 2A.166, for the term specified:

11       Susan Stryker, succeeding herself, term expired, seat 1, must be a member of the  
12 public from historical organizations including, but not limited to, organizations focused on the  
13 history of ethnic or racial minorities, sexual orientations, gender or any of the various other  
14 cultural communities within San Francisco, for the unexpired portion of a one-year term  
15 ending December 16, 2005.

16       Philip Choy, succeeding himself, term expired, seat 2, must be a member of the public  
17 from historical organizations including, but not limited to, organizations focused on the history  
18 of ethnic or racial minorities, sexual orientations, gender or any of the various other cultural  
19 communities within San Francisco, for the unexpired portion of a one-year term ending  
20 December 16, 2005.

21       Charles Striplen (residency requirement waived), succeeding himself, term expired,  
22 seat 3, must be a member from organizations or communities with extensive knowledge of the  
23 history or cultural traditions of an ethnic minority community within San Francisco with a focus  
24 on ancestral lineage or other historical and cultural links to the San Francisco Bay Area, for  
25 the unexpired portion of a one-year term ending April 21, 2006; and, be it

1 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 2 1. The membership of the San Francisco Museum and Historical Society Advisory  
3 Committee has a goal to be representative of the diversity of the City and County of  
4 San Francisco.
- 5 2. Applicant Charles Striplen, who is not a resident of San Francisco, is a person with  
6 experience that uniquely qualifies him/her to serve on the San Francisco Museum  
7 and Historical Society Advisory Committee.
- 8 3. The San Francisco Museum and Historical Society Advisory Committee has  
9 attempted to fill the position, for which Charles Striplen was nominated, with an  
10 individual who is a City resident and who has the specific experience, skills, and  
11 qualifications, but has been unable to do so at this time. The Rules Committee has  
12 certified that Charles Striplen is qualified to serve on the San Francisco Museum  
13 and Historical Society Advisory Committee.
- 14 4. After exercising due diligence, the Board of Supervisors concludes that there is no  
15 other possible representative, who is a resident of San Francisco and who has the  
16 specific experience, skills, or qualifications possessed by this applicant, and who is  
17 willing to serve on the San Francisco Museum and Historical Society Advisory  
18 Committee at this time; and, be it

19 FURTHER RESOLVED, That the Board of Supervisors waives the residency  
20 requirement for Charles Striplen, as allowed in cases where no qualified City resident, willing  
21 to serve, can be found, pursuant to Section 4.101 of the City Charter that requires person(s)  
22 appointed to boards, commissions, and advisory bodies established by legislative act of the  
23 Board of Supervisors to be resident(s) of the City and County of San Francisco.
