2 education services for young offenders in the county jail and after their release.]

3 **Resolution authorizing the Sheriff's Department to accept and expend a grant in the**  
4 **amount of \$311,603 from the Substance Abuse & Mental Health Services**  
5 **Administration for providing jail diversion opportunities involving integrated mental**  
6 **health and substance abuse treatment for incarcerated women**

7 WHEREAS, The Substance Abuse and Mental Health Services Administration has  
8 made available funding for jail diversion programs; and,

9 WHEREAS, Due to the need for jail diversion opportunities among female  
10 offenders with co-occurring disorders, the Sheriff's Department will provide a program to offer  
11 integrated mental health and substance abuse services; and,

12 WHEREAS, The grant identifies non-federal funds of \$127,363; and,

13 WHEREAS, The grant includes provision for indirect costs of \$3,876 for year one, be it

14 RESOLVED, That a grant award notification has been received from the  
15 Substance Abuse and Mental Health Services Administration; and, be it

16 FURTHER RESOLVED, That the grant provides for the creation of four positions  
17 as follows: 0.1 FTE class 1824 Principal Administrative Analyst at a salary of \$347 bi-weekly  
18 plus benefits; and 0.5 FTE class 8420, Rehabilitation Services Coordinator at a salary of  
19 \$1,347 bi-weekly; 0.5 FTE Health Worker II at a salary of \$909 bi-weekly; 0.75 FTE  
20 Epidemiologist II at a salary of \$1,514 bi-weekly; and, be it

21 FURTHER RESOLVED, That the Board of Supervisors of the City and County of San  
22 Francisco authorizes the Sheriff's Department to accept and expend \$311,603 in grant funds  
23 from the Substance Abuse and Mental Health Services Administration; and be it

24 FURTHER RESOLVED, That the City and County of San Francisco will adhere to the  
25 requirements of the Substance Abuse and Mental Health Services Administration and all




