8 WHEREAS, Lou Giraudo, owner of San Francisco’s oldest sourdough bread maker
9 Boudin Bakery and many other successful ventures, has been a longtime civic and business
10 leader in our City; and,

11 WHEREAS, Lou Giraudo recently agreed to serve as a mediator to facilitate a
12 resolution to the labor dispute between the California Pacific Medical Center (CPMC) and the
13 caregivers represented by SEIU United Healthcare Workers - West; and

14 WHEREAS, Lou Giraudo devoted his time, energy and skills to resolving the dispute
15 between the caregivers and CPMC and helped insure that the working men and women at
16 CPMC received an industry standard contract, and

17 WHEREAS, Because of the skillful mediation efforts of Lou Giraudo, caregivers at
18 St. Luke’s Hospital were able to reach agreement on an industry standard contract and avoid
19 a damaging work stoppage; and,

20 WHEREAS, Congresswoman Nancy Pelosi has been a tireless advocate on behalf of
21 the right of workers to organize in unions and demand quality working conditions and
22 compensation; and,

23 WHEREAS, Congresswoman Pelosi used her enormous influence to bring both sides
24 of the recent dispute to the table in order to facilitate a constructive discussion that resulted
25 in the resolution of the nearly three month long labor dispute; now, therefore be it,


