9 WHEREAS, Thierry Collomb is seeking issuance of type 48 on-sale general
10 license for Voda LLC, located at 56 Belden Street; and,

11 WHEREAS, The City Planning Department has verified that the area is properly
12 zoned; and

13 WHEREAS, The Police Department recommends that the liquor license
14 application be approved with conditions; now, therefore, be it

15 RESOLVED, That in accordance with Section 23958.4 of the California Business
16 and Professions Code, the Board of Supervisors of the City and County of San
17 Francisco hereby determines for the foregoing reasons that the issuance of type 48 on-
18 sale general license, to Thierry Collomb for Voda LLC, located at 56 Belden Street will
19 serve the public convenience and necessity of the people of the City and County of San
20 Francisco.

21 Conditions: (1) No noise shall be audible beyond the area under control of the
22 licensee; (2) Petitioners shall not permit their patrols or the general public to loiter or
23 congregate on the sidewalks adjacent to the licensed premises. Patrons standing in
24 line to enter the premises shall not be considered loitering or unlawfully gathering; (3)
25 The petitioner(s) shall be responsible for maintaining free of litter the area adjacent to

1 the premises over which they have control; (4) No alcoholic beverages shall be
2 consumed on any property adjacent to the premises over which the licensee has
3 control; (5) The sale of alcoholic beverages for consumption off the premises is strictly
4 prohibited.


