

1 [Additional contract funds to evaluate the integration of buprenorphine treatment into the  
2 SFGH AIDS Program.]

3 **Resolution authorizing the San Francisco Department of Public Health, Community**  
4 **Behavioral Health Services (SFDPH, CBHS), to enter retroactively into an agreement**  
5 **with the University of California San Francisco (UCSF), the primary contractor, and**  
6 **expend additional funds in the amount of \$351,939 to provide local and multi-site**  
7 **evaluation of the integration of buprenorphine treatment into the SFGH AIDS Program,**  
8 **and to add one (1.0) new position funded through this agreement; for the period of**  
9 **September 1, 2004 to August 31, 2009.**

11 WHEREAS, UCSF is the recipient of a grant award from the Department of Health and  
12 Human Services, National Institutes of Health, for a program titled, Integrating Buprenorphine  
13 into the SFGH AIDS Programs; and,

14 WHEREAS, UCSF and SFDPH, CBHS have agreed to enter into a subcontract  
15 agreement to participate in this project; and,

16 WHEREAS, UCSF has agreed to reimburse SFDPH, CBHS in the additional amount of  
17 \$351,939 from this award under the terms for Year 1 through Year 5 of this subcontract  
18 agreement; and,

19 WHEREAS, As a condition of receiving the funds, UCSF requires SFDPH, CBHS to  
20 enter into an agreement (The "Agreement"), a copy of which is on file with the Clerk of the  
21 Board of Supervisors in File No. 051815, which is hereby declared to be a part of  
22 this resolution as if set forth fully herein; and,

23 WHEREAS, One (1.0) position will be added through this agreement; and,

24 WHEREAS, The subcontract budget includes provision for indirect costs of \$23,915;  
25 and,

1 WHEREAS, This Resolution requires expedited review by the Board of Supervisors  
2 because we did not receive the subcontract until August 26, 2005; and,

3 WHEREAS, Resolutions authorizing the acceptance and expenditure of grant funds  
4 may be placed automatically on the consent agendas in committee, as they are usually  
5 considered to be routine items, and this resolution authorizes the acceptance and expenditure  
6 of grant funding; now, therefore, be it


7 RESOLVED, That SFDPH,CBHS is hereby authorized to enter retroactively into a  
8 subcontract agreement in the amount of \$351,939 with UCSF, the primary contractor; and, be  
9 it

10 FURTHER RESOLVED, That the Director of Health is authorized to enter into the  
11 Agreement on behalf of the City; and, be it

12 FURTHER RESOLVED, That the SFDPH is hereby authorized to add one (1.0)  
13 position funded through this agreement; and, be it

14 FURTHER RESOLVED, That the Controller is directed to designate the position funded  
15 under this agreement as a "G" or grant-funded position which would terminate when the  
16 agreement expires.
