15 Neighborhood Design Team will be responsible for coordination and day-to-day operations of  
16 the planning and implementation phases of this grant; and

17 WHEREAS, MOCJ will be responsible for the fiscal, programmatic and administrative  
18 reporting to OJP; now, therefore, be it

19 **RESOLVED**, That the City and County of San Francisco hereby authorizes MOCJ to  
20 retroactively accept and expend \$100,000 from the Office of Justice Programs, to administer  
21 the 2005 Weed and Seed Support Grant Program.




