

1 [Grant to develop training resources and a support network for injury prevention professionals  
2 in California, Kids' Plates initiative.]

3 **Resolution authorizing the San Francisco Department of Public Health (SFDPH) to**  
4 **accept and expend retroactively a new grant in the amount of \$55,000 from the San**  
5 **Diego State University Research Foundation (SDSU) for the injury prevention**  
6 **leadership initiative, Kids' Plates, and to enter into an agreement for the use of these**  
7 **funds; for the period of August 15, 2005, to June 30, 2007.**

9 WHEREAS, SFDPH has applied for and been awarded a grant in the amount of  
10 \$55,000 from SDSU for the injury prevention leadership initiative, Kids' Plates; and,

11 WHEREAS, As a condition of receiving the grant funds, SDSU requires the City to  
12 enter into an agreement (the "Agreement"), consisting of the SFDPH Application to SDSU for  
13 these funds and the grant award letter, copies of which are on file with the Clerk of the Board  
14 of Supervisors in File No. 051910, which is hereby declared to be a part of this  
15 resolution as if set forth fully herein; and,

16 WHEREAS, This Resolution requires expedited review by the Board of Supervisors  
17 because the Department was not forwarded the Agreement covering these funds until after  
18 August 15, 2005; and,

19 WHEREAS, Resolutions authorizing the acceptance and expenditure of grant funds  
20 may be placed automatically on consent agendas in committee, as they are usually  
21 considered to be routine items, and this resolution authorizes the acceptance and expenditure  
22 of grant funding; and,

23 WHEREAS, The grant budget includes a provision for indirect costs of \$6,775; now,  
24 therefore, be it


1 RESOLVED, That SFDPH is hereby authorized to accept and expend retroactively a  
2 new grant in the amount of \$55,000 from SDSU; and, be it

3 FURTHER RESOLVED, That SFDPH is hereby authorized to accept and expend the  
4 grant funds in accordance with the requirements set forth in the Agreement pursuant to San  
5 Francisco Administrative Code section 10-170-1; and, be it

6 FURTHER RESOLVED, That the Director of Health is authorized to enter into the  
7 agreement on behalf of the City; and, be it

8 FURTHER RESOLVED, That the Controller is directed to designate the positions  
9 funded under this agreement as "G" or grant-funded positions which would terminate when  
10 the agreement expires.
