6 to be right, and helped lead the charge against the people removal polices of "urban  
7 renewal," a fight she gallantly continues today; and

9 WHEREAS, Mary Rogers is known for her passionate intensity and her plain-talking  
10 eloquence in speaking about the issues of the day, whether it was a tragedy of racial hatred  
11 or the impoverished conditions of our urban poor; and

12 WHEREAS, Mary Rogers has been steadfast in the fight to protect the Fillmore's  
13 special legacy and the people who have lived there, as evidenced by her work with the  
14 Western Addition Project Area Committee; and

16 WHEREAS, Mary Rogers has worked tirelessly with the San Francisco  
17 Redevelopment Agency and the Housing Authority and engaged in the fragile social alliances  
18 that sought the common denominators of decency and humanity; and

20 WHEREAS, Mary Rogers continues to move mountains with her work in the Jazz  
21 Preservation District, Chair of the Juneteenth Committee, and as President of AGAPEE,  
22 among other notable activities; and

24 WHEREAS, Mary Rogers speaks to us all -- by calling witness to a City that sees its  
25 African American and working class populations shrink; by shaking the soul of San Francisco,


