

1 [Accept-expend State Grant Funds available under the Youth Soccer and Recreation
2 Development Program to fund the South of Market Area (SOMA) Park]

3 **Resolution authorizing the San Francisco Recreation and Park Department to**
4 **accept and expend a grant in the amount of \$630,000 for the development of the**
5 **South of Market Area (SOMA) Park, under the California Clean Water, Clean Air,**
6 **Safe Neighborhood Parks, and Coastal Protection Act of 2002 administered by**
7 **the California Department of Parks and Recreation, Office of Grants and Local**
8 **Services.**

10 WHEREAS, The California Department of Parks and Recreation have enacted
11 the California Clean Water, Clean Air, Safe Neighborhood Parks, and Coastal
12 Protection Act of 2002, which provides funds to the State of California for grants to
13 eligible Applicants; and,

14 WHEREAS, The California Department of Parks and Recreation has been
15 delegated the responsibility for the administration of the Youth Soccer and Recreation
16 Development Program and the grant Project shown above within the State, setting up
17 necessary procedures; and,

18 WHEREAS, the Applicant will enter into a contract with the State of California for
19 the Project; and,

20 WHEREAS, the grant term prohibit including indirect costs in the grant budget;
21 now, therefore, be it

22 RESOLVED, That the City and County of San Francisco hereby approves the
23 acceptance and expenditure of local assistance in the amount of \$630,000 for South of
24 Market Area (SOMA) Park from the Youth Soccer and Recreation Development

1 Program under the California Clean Water, Clean Air, Safe Neighborhood Parks, and
2 Coastal Protection Act of 2002; and, be it

3 FURTHER RESOLVED, That the City and County of San Francisco waives
4 inclusion of indirect costs in the grant budget; and, be it


5 FURTHER RESOLVED, That the City and County of San Francisco certifies that
6 Grantee has or will have sufficient funds to operate and maintain the project(s); and, be

8 FURTHER RESOLVED, That the City and County of San Francisco certifies that
9 Grantee has reviewed, understands and agrees to the General Provisions contained in
10 the Contract shown in the Procedural Guide; and, be it

11 FURTHER RESOLVED, That the City and County of San Francisco certifies that
12 the Project conforms to the recreation element of any applicable city or county general
13 plan; and, be it

14 FURTHER RESOLVED, That the City and County of San Francisco appoints the
15 General Manager of the Recreation & Park Department as agent to conduct all
16 negotiations, execute and submit all documents including, but not limited to
17 applications, agreements, payment requests and so on, which may be necessary for the
18 completion of the aforementioned project.






