5 WHEREAS, Lee Mallory, singer, songwriter, guitarist and international recording artist,  
6 was honored with the first annual Lee Mallory Day in San Francisco on his sixtieth birthday,  
7 January 10<sup>th</sup>, 2005; and

8 WHEREAS, Lee Mallory devoted his life to music for over forty years and was the  
9 heart and soul of San Francisco's thriving open mic community; and

10 WHEREAS, Lee Mallory survived the commercial music industry and became an  
11 independent singer-songwriter who encouraged others in the independent music movement;  
12 and

13 WHEREAS, Lee Mallory viewed his life as a cautionary tale of "lust for life and other  
14 adventures," and became an advocate for musicians getting tested for Hepatitis C; and

15 WHEREAS, Without songwriters, there would be no LPs, CDs, EPs, MP3s, or songs to  
16 sample; and

17 WHEREAS, Lee Mallory poured every ounce of his soul into every note he played and  
18 sang; and

19 WHEREAS, Lee Mallory loved San Francisco for its "beautiful bay, beautiful women  
20 and beautiful music;" and

21 WHEREAS, Lee Mallory passed from this earth on March 21<sup>st</sup>, 2005 in the  
22 Emergency Department of UCSF with his lady by his side; and

23 WHEREAS, San Francisco State University's Lee Mallory Scholarship will assist Music  
24 and Recording Industry students who serve their community while serving their gift; and

1           WHEREAS, Lee Mallory Day will be celebrated at The Hotel Utah with performances  
2 by three women whose music he championed, Crystal and The Wolves, Toy House and Nina  
3 Jo Smith; now, therefore, be it

5 January 10<sup>th</sup>, 2006, Lee Mallory Day in honor of Lee Mallory and all singer-songwriters.


