3 **Resolution authorizing the Chief of Police for the City and County of San Francisco to**  
4 **retroactively accept and expend grant funds in the amount of \$225,542 made available**  
5 **through the United States Department of Justice, Office of Community Oriented**  
6 **Policing Services (COPS) for a project entitled Secure Our Schools.**

8 WHEREAS, The Chief of Police of the City and County of San Francisco desires to  
9 undertake a certain project designated Secure Our Schools to be funded from funds made  
10 available through the U.S. Department of Justice, Office of Community Oriented Policing  
11 Services (COPS); and,

12 WHEREAS, the San Francisco Unified School District will collaborate with the police  
13 department by providing matching funds and services to ensure compliance with grant  
14 activities; and,

15 WHEREAS, all positions funded under this grant program shall be "G" coded; and,

16 WHEREAS, The grant terms prohibited including indirect costs in the grant budget;  
17 now, therefore, be it

18 RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in  
19 the grant budget; and be it

20 FURTHER RESOLVED, That the Chief of Police of the City and County of San  
21 Francisco is authorized on behalf of the City and County of San Francisco to retroactively  
22 accept and expend continued funding for this project from the USDOJ-COPS office; and be it

23 FURTHER RESOLVED, That The Chief of Police of the City and County of San  
24 Francisco is authorized to execute on behalf of the City and County of San Francisco the

1 necessary Grant Agreement for this project including any extensions, funding augmentations  
2 from the USDOJ-COPS office, or amendments thereof; and be it



3 FURTHER RESOLVED, That it is agreed that any liability arising out of the

5 responsibility of the grantee and the authorizing agency; and be it


6 FURTHER RESOLVED, That grant funds received hereunder shall not be used to




