9 WHEREAS, Lost in the Fog has earned more than \$880,000 in career earnings over a
10 span of 11 races; and

11 WHEREAS, Lost in the Fog is owned by Harry J. Aleo of Noe Valley and trained by Greg
12 Gilchrist of Golden Gate Field; and

13 WHEREAS, Lost in the Fog has captured the hearts of racing fans across the nation with
14 his streak of 8 consecutive wins during the 2005 racing season; and

15 WHEREAS, Lost in the Fog beat his competition by an average of more than five lengths
16 during his 2005 streak; and

17 WHEREAS, Lost in the Fog was awarded the Eclipse Award as the nation's best sprinter
18 receiving more than 80% of the votes; and

19 WHEREAS, Lost in the Fog became only the second horse in Northern California History
20 to receive one of horse racing's annual honors; and

21 WHEREAS, Lost in the Fog was only able to achieve his amazing feats thanks to the
22 wisdom and guidance of owner Harry J. Aleo and trainer Greg Gilchrist who resisted the
23 appeal to rush the Colt into the 2005 Kentucky Derby, deciding to keep Lost in the Fog in




