10 offer her assistance to avoid an impasse; and

12 reached a tentative agreement that ensures continued operation of the Symphony in a  
13 collaborative fashion; and,

14 WHEREAS, Both parties have worked in good faith, providing a model for labor  
15 relations in a town where we all agree much more often than we disagree; now, therefore, be




