4 WHEREAS, in December 2004, the Board of Supervisor's created the Arts Task Force
5 under Resolution No. 781-04, a copy of which is on file with the Clerk of the Board of
6 Supervisors in File No. 041621 and is hereby declared to be a part of this resolution as it set
7 forth fully herein; and

8 WHEREAS, in May 2005, the Arts Task Force was extended to August 1, 2005 and
9 again in November 2005, to submit it's final report to the Board of Supervisors under
10 Resolution No. 316-05; a copy of which is on file with the Clerk of the Board of Supervisors in
11 File No. 050703 and is hereby declared to be a part of this resolution as it set forth fully herein;

13 WHEREAS, the Arts Task Force has a membership representative of City
14 Departments, artists and nonprofit community groups working with Artists, as well the larger
15 and smaller budgeted arts organizations and has been beneficial to the City of San Francisco
16 and will result in the establishment of a coordinated delivery system for the Arts in San
17 Francisco; and

18 WHEREAS, the Task Force is now in the final stages of drafting their recommendations
19 and will deliver their report in February 2006; and request an extension of the Task Force to
20 oversee the implementation of the short and long term recommendations of the Task Force;
21 now therefore be It

24 Task Force, through the implementation of the ArtsTask Force recommendations.




