14 officials of the City and County of San Francisco, including the Board of Supervisors, the Mayor,

18 Sylvia's exemplary leadership and knowledge of campaign finance, lobbying, and governmental
19 ethics laws; and,

21 governmental and legal ethics, and in her spare time has authored a treatise on the federal
22 False Claims Act; and,

23 WHEREAS, Ms. Sylvia has played an integral role in providing ethics training to City
24 officials and employees and has co-authored the City Attorney's Good Government Legal
25 Guide since its inception; and

1 WHEREAS, Throughout her career in City government, Ms. Sylvia has excelled as a
2 problem solver, helping to protect the integrity and honor of City officials and their
3 governmental decisions; and,

4 WHEREAS, As a supervisor of the City Attorney's Ethics and Elections Team, Ms.
5 Sylvia has motivated her colleagues to do their finest legal work and realize their maximum
6 potential, has done an outstanding job in implementing training programs in substantive areas
7 of the law, and has been a delight for her clients to work with; and,

8 WHEREAS, Ms. Sylvia's adherence to the highest standards of ethical conduct has
9 ennobled public service, her strong work ethic has set an example for others, and her legal
10 skills, calm demeanor, caring nature and thoughtfulness have earned the respect of all of her

13 her skill and proficiency, for her astute counsel, good judgment, leadership, commitment,




