3 **Resolution determining that the issuance of a Type 42 on-sale beer and wine**
4 **public premises license to Raimondo Morrone for Space Gallery located at 1141**
5 **Polk Street, will serve the public convenience and necessity of the people of the**
6 **City and County of San Francisco, in accordance with Section 23958.4 of the**
7 **California Business and Professions Code, with conditions.**

9 WHEREAS, Raimondo Morrone is seeking issuance of a Type 42 on-sale beer
10 and wine public premises license for Space Gallery, located at 1141 Polk Street; and,

11 WHEREAS, The Planning Department has verified that the area is properly
12 zoned; and recommends approval with conditions; and,

13 WHEREAS, The Police Department recommends that the liquor license
14 application be approved with conditions; now, therefore, be it

15 RESOLVED, That in accordance with Section 23958.4 of the California Business
16 and Professions Code, the Board of Supervisors of the City and County of San
17 Francisco hereby determines for the foregoing reasons that the issuance of a Type 42
18 on-sale beer and wine public premises license, to Raimondo Morrone for Space Gallery,
19 located at 1141 Polk Street will serve the public convenience and necessity of the
20 people of the City and County of San Francisco.

21 Conditions: (1) The petitioner shall be responsible for maintaining free of litter
22 the area adjacent to the premises over which they have control; (2) No noise shall be
23 audible beyond the area under control of the license; (3) Petitioner shall not permit their
24 patrons or the general public to loiter or congregate on the sidewalks adjacent to the
25 licensed premises; (4) Sales and service of alcoholic beverages shall be permitted daily

1 between the hours of 11:00 a.m. and midnight; (5) The premises shall be maintained as
2 a bona fide art gallery (a room devoted to the exhibition of works of art) with the sale
3 and service of beer and wine. The petitioner shall stock and offer for sale a substantial
4 assortment of art and/or merchandise commonly associated with and sold to persons in
5 the community.
