8 RESOLVED, That the property owners declined to request an administrative review
9 hearing of the DPW Director's determination that said owners were obligated to repay the
10 costs of repair to the City and County, and proper notice was provided to the owner concerning
11 the right to a hearing. The Board of Supervisors hereby confirms that report of assessment
12 costs described in DPW Order 175, 878, including modifications as the Board deems at
13 necessary, be restored to the City and County revolving fund; and be it

14 FURTHER RESOLVED, That a copy of this resolution and a copy of said itemized
15 Report of Assessment Costs confirmed by the Board shall be transmitted to the Controller and
16 Tax Collector of the City and County, whereupon it shall be the duty of said officers to add the
17 amount of each assessment to the next regular bill for taxes levied against each respective
18 parcel of land, and thereafter each said amount shall be collected at the same time and in the
19 same manner as ordinary City and County taxes are collected, and shall be subject to the
20 same procedure under foreclosure and sale in case of delinquency as provided for ordinary
21 taxes of the City and County; and, be it

22 FURTHER RESOLVED, That all monies received in payment of the assessments
23 shall be credited to the revolving fund provided for in Section 706.8 of the Public Works
24 Code, except that the portion of the assessments attributable to the cost of City
