3 **Resolution enacting and rescinding parking regulations at various locations.**

5 RESOLVED, That, in accordance with the provisions of the California Vehicle Code
6 and the San Francisco Traffic Code, the following regulations governing the parking of
7 vehicles are hereby enacted or rescinded as designated below:

8 **NO PARKING ANYTIME - RESCIND**
9 **TOW-AWAY, NO STOPPING ANYTIME, 7 AM TO 3 PM, MONDAY THROUGH FRIDAY -**
10 **RESCIND**

11 Pine Street, south side, from Montgomery Street to 155 feet easterly (creates new
12 metered parking, but maintains Tow-Away 3 PM to 7 PM, Monday through
Friday).

13 **TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

14 Lake Merced Boulevard, northbound, right turn lane onto Font Boulevard to the limit of
15 the existing angle parking on the south side of Font Boulevard.

16 **4-HOUR PARKING TIME LIMIT, 7:00 AM TO 6:00 PM, EXCEPT SUNDAY - RESCIND**
17 **PERPENDICULAR (90-DEGREE ANGLE) PARKING - ESTABLISH**
18 **2-HOUR PARKING TIME LIMIT, 7:00 AM TO 6:00 PM, EXCEPT SUNDAY - ESTABLISH**

19 Mississippi Street, east side, between Cesar Chavez and northern terminus.

20 **TOW-AWAY, NO PARKING - ESTABLISH**

21 Mississippi Street, west side, between Cesar Chavez Street and northern terminus.

22 **PERPENDICULAR (90-DEGREE ANGLE) PARKING -ESTABLISH**

23 Irwin Street, north side, between 7th and 8th Streets.

24 **TOW-AWAY, NO PARKING, 7 AM TO 9 AM, MONDAY THROUGH FRIDAY - ESTABLISH**

25 17th Street, north side, from 25 to 58 feet east of Utah Street.

1 **TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

2 1122 Folsom Street, north side, from Langton Street to 48 feet westerly; and,

4 1168 Folsom Street, north side, from the west property line to the east property line (50-foot
5 zone) (both parking restrictions are in conjunction with implementation of sidewalk
6 bulbs).

6 **TOW-AWAY, NO STOPPING, 7 AM TO 9 AM AND 4 PM TO 7 PM, MONDAY THROUGH
7 FRIDAY - RESCIND**

7 **TOW-AWAY, NO STOPPING, 4 PM TO 6 PM, MONDAY THROUGH FRIDAY - ESTABLISH**

8 Franklin Street, west side, from Turk Street to Golden Gate Avenue (replaces existing
9 tow-away regulations).

10 **TOW-AWAY, NO STOPPING, 4 PM TO 6 PM, MONDAY THROUGH FRIDAY - ESTABLISH**

11 Franklin Street, west side, from Turk Street to 80 feet northerly.

12 **TOW-AWAY, LANE MUST TURN LEFT - RESCIND**

13 Franklin Street, northbound, at Turk Street.

14 **RESIDENTIAL PERMIT PARKING AREA "U" (2-HOUR TIME LIMIT, 8 AM TO 10 PM,
15 EVERYDAY) - ESTABLISH**

16 Rodgers Street, east side, between Folsom Street and the southern terminus (unit
17 block).

18 **TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

19 San Jose Avenue, east side, from 10 feet north of the north crosswalk at Farallones
20 Street to 190 feet southerly;

21 San Jose Avenue, west side, from Farallones Street to 173 feet northerly;

22 San Jose Avenue, east side from Lakeview Avenue to 150 feet southerly;

23 San Jose Avenue, west side, from Lakeview Avenue to 150 feet northerly;

24 San Jose Avenue, east side, from 50 feet north of the northern crosswalk at Mount
25 Vernon Avenue to 260 feet southerly;

1 San Jose Avenue, west side, from Mount Vernon Avenue to 178 feet northerly; and,
2 McCoppin Street, south side, between Market Street and Elgin Park

3 **TOW-AWAY, NO PARKING ANYTIME - ESTABLISH**

4 McCoppin Street, north side, west of Valencia Street to terminus.

5 **UNMETERED MOTORCYCLE PARKING - ESTABLISH**

6 Fillmore Street, east side, at the O'Farrell Street intersection (36 foot zone
7 accommodating 10 unmetered motorcycle parking spaces).

8 **PARKING METER AREA 3 (9AM-6PM, MONDAY THROUGH SATURDAY) - ESTABLISH**

9 Parker Avenue, west side, from Geary Boulevard to 50 feet southerly (replaces
10 existing green zone with two 30-minute meters).


11 **PARKING METER AREA 4 - ESTABLISH**

12 Stockton Street, east side, from North Point Street to 60 feet northerly (adds 3 meters).

13 **RESIDENTIAL PERMIT PARKING AREA "J" (2-HOUR TIME LIMIT, 8 AM - 5 PM,
14 MONDAY THROUGH FRIDAY) - ESTABLISH**

15 Hillway Avenue, east side, from Carl Street to the south property line of #40 Hillway
16 Avenue

17 Categorically exempt from Environmental Review Class
18 1(c)(9) changes in the traffic and parking regulations
19 where such changes do not establish a higher speed
20 limit or result in more than a negligible increase in the
21 use of the street.

NO PARKING ANYTIME - RESCIND

TOW-AWAY, NO STOPPING ANYTIME, 7 AM TO 3 PM, MONDAY THROUGH FRIDAY - RESCIND

Pine Street, south side, from Montgomery Street to 155 feet easterly (creates new metered parking, but maintains Tow-Away 3 PM to 7 PM, Monday through Friday).

TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH

Lake Merced Boulevard, northbound, right turn lane onto Font Boulevard to the limit of the existing angle parking on the south side of Font Boulevard.

4-HOUR PARKING TIME LIMIT, 7:00 AM TO 6:00 PM, EXCEPT SUNDAY - RESCIND

PERPENDICULAR (90-DEGREE ANGLE) PARKING - ESTABLISH

2-HOUR PARKING TIME LIMIT, 7:00 AM TO 6:00 PM, EXCEPT SUNDAY - ESTABLISH

Mississippi Street, east side, between Cesar Chavez and northern terminus.

TOW-AWAY, NO PARKING - ESTABLISH

Mississippi Street, west side, between Cesar Chavez Street and northern terminus.

PERPENDICULAR (90-DEGREE ANGLE) PARKING - ESTABLISH

Irwin Street, north side, between 7th and 8th Streets.

TOW-AWAY, NO PARKING, 7 AM TO 9 AM, MONDAY THROUGH FRIDAY - ESTABLISH

17th Street, north side, from 25 to 58 feet east of Utah Street.

TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH

1122 Folsom Street, north side, from Langton Street to 48 feet westerly; and,

1168 Folsom Street, north side, from the west property line to the east property line (50-foot zone) (both parking restrictions are in conjunction with implementation of sidewalk bulbs).

TOW-AWAY, NO STOPPING, 7 AM TO 9 AM AND 4 PM TO 7 PM, MONDAY THROUGH FRIDAY - RESCIND

TOW-AWAY, NO STOPPING, 4 PM TO 6 PM, MONDAY THROUGH FRIDAY - ESTABLISH

Franklin Street, west side, from Turk Street to Golden Gate Avenue (replaces existing tow-away regulations).

TOW-AWAY, NO STOPPING, 4 PM TO 6 PM, MONDAY THROUGH FRIDAY - ESTABLISH

Franklin Street, west side, from Turk Street to 80 feet northerly.

TOW-AWAY, LANE MUST TURN LEFT - RESCIND

Franklin Street, northbound, at Turk Street.

RESIDENTIAL PERMIT PARKING AREA "U" (2-HOUR TIME LIMIT, 8 AM TO 10 PM, EVERYDAY) - ESTABLISH

Rodgers Street, east side, between Folsom Street and the southern terminus (unit block).

TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH

San Jose Avenue, east side, from 10 feet north of the north crosswalk at Farallones Street to 190 feet

southerly;

San Jose Avenue, west side, from Farallones Street to 173 feet northerly;

San Jose Avenue, east side, from Lakeview Avenue to 150 feet southerly;

San Jose Avenue, west side, from Lakeview Avenue to 150 feet northerly;

San Jose Avenue, east side, from 50 feet north of the northern crosswalk at Mount Vernon Avenue to 260 feet southerly;

San Jose Avenue, west side, from Mount Vernon Avenue to 178 feet northerly; and,

McCoppin Street, south side, between Market Street and Elgin Park

TOW-AWAY, NO PARKING ANYTIME - ESTABLISH

McCoppin Street, north side, west of Valencia Street to terminus.

UNMETERED MOTORCYCLE PARKING - ESTABLISH

Fillmore Street, east side, at the O'Farrell Street intersection (36 foot zone accommodating 10 unmetered motorcycle parking spaces).

PARKING METER AREA 3 (9AM-6PM, MONDAY THROUGH SATURDAY) - ESTABLISH

Parker Avenue, west side, from Geary Boulevard to 50 feet southerly (replaces existing green zone with two 30-minute meters).

PARKING METER AREA 4 - ESTABLISH

Stockton Street, east side, from North Point Street to 60 feet northerly (adds 3 meters).

RESIDENTIAL PERMIT PARKING AREA "J" (2-HOUR TIME LIMIT, 8 AM - 5 PM, MONDAY THROUGH FRIDAY) - ESTABLISH


Hillway Avenue, east side, from Carl Street to the south property line of #40 Hillway Avenue


