3 **Resolution enacting and rescinding traffic regulations on various streets.**

5 RESOLVED, That, in accordance with the provisions of the California Vehicle Code
6 and the San Francisco Traffic Code, the following regulations governing the movement of
7 vehicles are hereby enacted or rescinded as designated below:

8 **ONE-WAY STREET (SOUTHBOUND) - RESCIND**

9 Elgin Park, between McCoppin Street and Duboce Avenue
10

11 **ONE-WAY STREET (EASTBOUND) - RESCIND**

12 **ONE-WAY STREET (WESTBOUND) - ESTABLISH**

13 McCoppin Street, between Market Street and Elgin Park

14 **BICYCLE LANES - ESTABLISH**

15 McCoppin Street, north side, west of Valencia Street to terminus.

16 **BICYCLE LANES - ESTABLISH**

17 Laguna Honda Boulevard, both sides, between Portola Drive and Vasquez Avenue

18 **LEFT TURN BIKE LANE - ESTABLISH**

19 Laguna Honda Boulevard, southbound, between Ulloa Street and Portola Drive

20 **BICYCLE LANES - EXTEND**

21 Potrero Avenue, southbound, from 120 feet south of 25th Street to Cesar Chavez
22 Street.

23 **NO LEFT TURN, 4 PM TO 7 PM, MONDAY THROUGH FRIDAY - ESTABLISH**

24 Southbound Masonic Avenue at Grove Street.


