10 passion for many things that enhance and improve the culture and well being of our society  
11 and its citizenry, and who passed away in October of 2003; and,

12 WHEREAS, LORAYNE HABATA generously included the San Francisco Public  
13 Library's Western Addition Branch Library among the beneficiaries of the LORAYNE  
14 HABATA'S estate; and,

15 WHEREAS, the San Francisco Public Library anticipates receiving a distribution of  
16 \$65,627.76 from the LORAYNE HABATA estate; and,

17 WHEREAS, upon completion of the renovation of the Western Addition Branch Library,  
18 the LORAYNE HABATA bequest would provide funding for landscape improvements to the  
19 new, prominent entrance of the Western Addition Branch Library; and,

20 WHEREAS, the City recognizes the generosity of LORAYNE HABATA with sincere  
21 appreciation; now, therefore, be it


22 RESOLVED, That the Board of Supervisors hereby authorizes the City Librarian of the  
23 San Francisco Public Library to accept and expend \$65,627.76 from the LORAYNE HABATA  
24 estate for landscape improvements in coordination with the renovation of the Western  
25 Addition Branch Library scheduled to begin in summer 2006, with completion in late 2007.
