3 **Resolution determining that the transfer of a Type 47 on-sale general for bona**
4 **fide public eating place license from 1695 Market Street to 86 Second Street, and**
5 **the exchange of said license for a Type 48 on-sale general public premises**
6 **license for M & M Group Assets, Inc. dba DaDa SF Studio, will serve the public**
7 **convenience and necessity of the people of the City and County of San**
8 **Francisco, in accordance with Section 23958.4 of the California Business and**
9 **Professions Code with conditions.**

11 WHEREAS, M & M Group Assets, Inc. is seeking transfer and exchange of a
12 Type 47 on-sale general for bona fide public eating place license for a Type 48 on-sale
13 general public premises license for DaDa SF Studio located at 86 Second Street; and,

14 WHEREAS, The Planning Department has verified that the area is properly
15 zoned; and,

16 WHEREAS, The Police Department recommends that the liquor license
17 application be approved with conditions; now, therefore, be it

18 RESOLVED, That in accordance with Section 23958.4 of the California Business
19 and Professions Code, the Board of Supervisors of the City and County of San
20 Francisco hereby determines for the foregoing reasons that the transfer and exchange
21 of a Type 47 on-sale general for bona fide public eating place license for a Type 48 on-
22 sale general public premises license from 1695 Market Street to 86 Second Street for M
23 & M Group Assets, Inc. dba DaDa SF Studio, will serve the public convenience and
24 necessity of the people of the City and County of San Francisco.

1 Conditions: (1) The premises shall be maintained as a bona fide art gallery (a
2 room or building devoted to the exhibition of works of art) with the sale of beer, wine and
3 distilled spirits. The premises shall be used for no other purpose. (2) The petitioner(s)
4 shall stock and offer for sale a substantial assortment of art and/or merchandise
5 commonly associated with and sold to persons in the community. (3) The sale of
6 alcoholic beverages for consumption off the premises is strictly prohibited. (4) The
7 petitioner(s) shall be responsible for maintaining free of litter the area adjacent to the
8 premises over which they have control. (5) No noise shall be audible beyond the area
9 under control of the licensee. (6) The petitioner(s) shall not display any magazine,
10 video, printed or painted material, which contains pictures depicting : (a) Acts or
11 simulated acts or sexual act, which are prohibited by law. (b) Any person being
12 touched, caressed or fondled in a manner prohibited by law. (c) Scenes wherein
13 artificial devices or inanimate objects are employed to depict, or drawings are employed
14 to portray, any other prohibited activities described above. (7) No pool or billiard tables
15 may be maintained on the premises. (8) There shall be no coin operated games or
16 video machines upon the premises at anytime. (9) There shall be no exterior
17 advertising or sign of any type, including advertising to the exterior from within,
18 promoting or indicating the availability of alcoholic beverages. Interior displays of
19 alcoholic beverages or signs, which are clearly visible to the exterior, shall constitute a
20 violation of this condition. (10) Sales, service and consumption of alcoholic beverages
21 shall not be permitted only between the hours of 12:00 noon to 12:00 midnight Sunday
22 through Wednesday and 12:00 noon to 2:00 a.m. Thursday through Saturday. (11)
23 Petitioner(s) shall regularly police the area under their control in an effort to prevent the
24 loitering of persons about the premises.




