14 DTIS and the Mayor's Office to collaborate in finalizing a plan and finding funding necessary
15 to televise the SFUSD Board Meetings on SFGTV Channel 26; and be it

16 FURTHER RESOLVED, that the San Francisco Unified School District consider as part
17 of their Prop H in-kind services proposal to the City include funding to ensure SFUSD is able
18 to air their Board Meetings on SFGTV Channel 26; and be it

19 FURTHER RESOLVED, that the City & County of San Francisco Board of Supervisors
20 Budget & Finance Committee engage in discussions for the FY 2006-2007 Budget around
21 appropriating the necessary funding to televise the SFUSD Board Meetings on SFGTV
22 Channel 26.




