

1 [Proposition J Contract/Certification of Specified Contracted-Out Services previously approved  
2 for Enterprise Departments.]

3 **Resolution concurring with the Controller's certification previously approved under**  
4 **Proposition J that services can be performed by private contractor for a lower cost**  
5 **than similar work performed by City and County employees, for the following services:**  
6 **employee parking management, information booth, public parking management and**  
7 **shuttle bus services (Airport); paratransit and security services (MTA); citation**  
8 **information, janitorial and landscaping, coin counting and collection, security, and**  
9 **towing services (MTA Parking & Traffic); janitorial and security services (Port).**

10 WHEREAS, The Electorate of the City and County of San Francisco passed  
11 Proposition J in November 1976, allowing City and County Departments to contract with  
12 private companies for specific services which can be performed for a lower cost than similar  
13 work by City and County employees (Charter Section 10.104.15); and,

14 WHEREAS, The Board of Supervisors has previously approved outside contracts  
15 under Proposition J for the services listed below; and,

16 WHEREAS, The Controller has determined that a Purchaser's award of a contract for  
17 the services listed below to a private contractor will continue to achieve substantial cost  
18 savings for the City; and,

19 WHEREAS, The Controller's certification, which confirms that said services can be  
20 performed at lower costs to the City and County by private contractor than by employees of  
21 the City and County, is on file with the Clerk of the Board of Supervisors in File  
22 No. 060564, which is hereby declared to be part of this resolution as if set forth fully  
23 herein; now, therefore be it;

24 RESOLVED, That the Board of Supervisors hereby concurs with the Controller's  
25 certification and approves the Proposition J Resolution concerning the Purchaser's award of a

1 contract to a private contractor for the services listed below for the period of July 1, 2006  
 2 through June 30, 2007.


