3 **Resolution authorizing the Municipal Transportation Agency to accept and expend \$199,992 of**
4 **Carl Moyer grant funds from the Bay Area Air Quality Management District to purchase and**
5 **install new engines on 12 articulated motor coaches.**

7 WHEREAS, The Carl Moyer Program provides grants to reduce exhaust emissions from heavy-
8 duty diesel engines; and,

9 WHEREAS, The Bay Area Air Quality Management District (BAAQMD) is authorized to
10 make Carl Moyer Program funds available to eligible applicants; and,

11 WHEREAS, The Municipal Transportation Agency (MTA) is an eligible applicant for grant
12 funds under the Carl Moyer Program; and

13 WHEREAS, The MTA has applied for \$199,992 in Carl Moyer grant funds to purchase and
14 install new engines on 12 articulated motor coaches; and

15 WHEREAS, There is no allowance for indirect costs; and

16 WHEREAS, On April 18, 2006, the MTA Board of Directors approved Resolution No. 06-038,
17 which authorized the acceptance and expenditure of \$199,992 in Carl Moyer grant funds for the
18 purchase and installation of new engines on 12 articulated motor coaches, and requested that the Board
19 of Supervisors approve the acceptance and expenditure of the grant funds; now, therefore, be it


20 RESOLVED, That the Board of Supervisors authorizes the MTA to accept and expend
21 \$199,992 of Carl Moyer grant funds from BAAQMD to purchase and install new engines on 12
22 articulated motor coaches; and, be it


23 FURTHER RESOLVED, That the Board of Supervisors waives inclusion of indirect costs in
24 the grant budget; and, be it,

1 FURTHER RESOLVED, That the MTA is authorized to execute any and all agreements
2 necessary to complete the transfer of the funds.




