3 **Resolution designating the Examiner and the Chronicle to be the official**  
4 **newspapers of the City and County of San Francisco for the category of Type 1**  
5 **consecutive day official advertising, for the period commencing July 1, 2006 and**  
6 **ending June 30, 2007.**

8 WHEREAS, in each year, the Board of Supervisors shall designate the official  
9 newspaper of the City and County of San Francisco, pursuant to Article IX, Section 2.80-1 and  
10 2.81 of the San Francisco Administrative Code; now therefore, be it

11 RESOLVED, that the Examiner and Chronicle, are newspapers of general circulation  
12 published in the City and County of San Francisco for the dissemination of local or telegraphic  
13 news and intelligence of a general character, having a bona fide circulation of at least 50,000  
14 copies per calendar week, printed in the City and County on three or more days in a calendar  
15 week, are hereby designated as the official newspapers of the City and County of San  
16 Francisco, commencing July 1, 2006 for the publication of all official advertising of the City  
17 and County which is required by law, other than the provisions of Section 2.103 of the Charter  
18 as they relate to special meetings of the Board of Supervisors and its special or standing  
19 committees, to be published one time, and all official advertising of the City and County which  
20 is required by law to be published more than one, but not more than three times per week for  
21 a specified number of weeks, and, be it

22 FURTHER RESOLVED, that the Purchasing Division is hereby authorized to enter into  
23 a contract with the Examiner and the Chronicle said contract must be in accordance with all  
24 the contracting requirements of the City and County of San Francisco.


