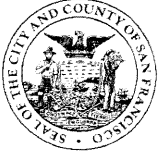
7 WHEREAS, in each year, the Board of Supervisors shall designate the official  
8 newspaper of the City and County of San Francisco, pursuant to Article IX, Section 2.80-1 and  
9 2.81 of the San Francisco Administrative Code; now therefore, be it

10 RESOLVED, that the Examiner and the Chronicle, are newspapers of general  
11 circulation published in the City and County of San Francisco for the dissemination of local or  
12 telegraphic news and intelligence of a general character, having a bona fide circulation of at  
13 least 50,000 copies per calendar week, printed in the City and County on three or more days  
14 in a calendar week, is hereby designated as the official newspapers of the City and County of  
15 San Francisco, commencing July 1, 2006 for the publication of all official advertising of the  
16 City and County which is required by law, other than the provisions of Section 2.103 of the  
17 Charter as they relate to special meetings of the Board of Supervisors and its special or  
18 standing committees, to be published one time, and all official advertising of the City and  
19 County which is required by law to be published more than one, but not more than three times  
20 per week for a specified number of weeks, and, be it

21 FURTHER RESOLVED, that the Office of Contract Administration is hereby authorized  
22 to execute a contract with the Examiner and the Chronicle said contract must be in  
23 accordance with all the contracting requirements of the City and County of San Francisco.


