4 **Hospital to accept a gift in the amount of \$146,041 from the Avon Foundation, via the**
5 **San Francisco General Hospital Foundation, for the purchase of technical and**
6 **logistical services in support of the operation of the mobile mammography facility**
7 **vehicle, donated to the City in 2004, by the University of California, San Francisco. The**
8 **mobile mammography facility vehicle provides services to indigent and under-served**
9 **women in San Francisco.**

11 WHEREAS, the University of California, San Francisco (UCSF) is a not-for-profit public
12 medical academic institution engaged in the provision of health-care services to
13 disadvantaged residents of San Francisco, among other populations; and,

14 WHEREAS, San Francisco General Hospital (SFGH) is a public hospital that provides
15 health-care services to the indigent and under-served residents of San Francisco; and,

16 WHEREAS, the mobile mammography facility vehicle (Mammovan), including the
17 equipment, software, peripherals, and manuals was purchased by UCSF for the purposes of
18 providing mammography services to indigent and under-served women in San Francisco;
19 and,

20 WHEREAS, SFGH has committed to continue providing mobile mammography
21 services to indigent and under-served women in San Francisco; and

22 WHEREAS, SFGH via the San Francisco General Hospital Foundation has received
23 grant funding from the Avon Foundation for the continuation of the mobile mammography
24 project initiated by UCSF; and




