4 **terms ending September 4, 2009, to the Assessment Appeals Board #1.**

6 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
7 does hereby appoint the hereinafter designated persons to serve as members of the
8 Assessment Appeals Board #1, pursuant to the provisions of the Revenue and Taxation
9 Code, Section 1623, and the San Francisco Administrative Code, Section 2B.1 through 2B.11,
10 for the term specified:

11 Alec Lambie, succeeding himself, term expiring September 4, 2006, seat 2, must meet
12 the eligibility criteria set forth in Section 1624.05 of the California Revenue and Taxation Code
13 as follows: a person shall not be eligible for nomination for membership on an assessment
14 appeals board unless he or she has a minimum of five years' professional experience in this
15 state as one of the following: certified public accountant or public accountant, licensed real
16 estate broker, attorney, or property appraiser accredited by a nationally recognized
17 professional organization for a three-year term ending September 4, 2009.

18 Lawrence Lee, succeeding Gordon Huseby, term expiring September 4, 2006, seat 5,
19 must meet the eligibility criteria set forth in Section 1624.05 of the California Revenue and
20 Taxation Code as follows: a person shall not be eligible for nomination for membership on an
21 assessment appeals board unless he or she has a minimum of five years' professional
22 experience in this state as one of the following: certified public accountant or public
23 accountant, licensed real estate broker, attorney, or property appraiser accredited by a
24 nationally recognized professional organization for a three-year term ending September 4,
25 2009.

1 Hayes Miles, succeeding himself, term expiring September 4, 2006, seat 6, must meet
2 the eligibility criteria set forth in Section 1624.05 of the California Revenue and Taxation Code
3 as follows: a person shall not be eligible for nomination for membership on an assessment
4 appeals board unless he or she has a minimum of five years' professional experience in this
5 state as one of the following: certified public accountant or public accountant, licensed real
6 estate broker, attorney, or property appraiser accredited by a nationally recognized
7 professional organization for a three-year term ending September 4, 2009.

8 David Wilbur, succeeding himself, term expiring September 4, 2006, seat 8, must meet
9 the eligibility criteria set forth in Section 1624.05 of the California Revenue and Taxation Code
10 as follows: a person shall not be eligible for nomination for membership on an assessment
11 appeals board unless he or she has a minimum of five years' professional experience in this
12 state as one of the following: certified public accountant or public accountant, licensed real
13 estate broker, attorney, or property appraiser accredited by a nationally recognized
14 professional organization for a three-year term ending September 4, 2009.
