5 RESOLVED, That, in accordance with the provisions of the California Vehicle Code
6 and the San Francisco Traffic Code, the following regulations governing the parking of
7 vehicles are hereby enacted or rescinded as designated below:

8 **RESIDENTIAL PERMIT PARKING AREA "G" (2-HOUR TIME LIMIT, 8 AM - 6 PM,**
9 **MONDAY THROUGH FRIDAY) - ESTABLISH**

10 Geary Boulevard, north side, between Baker and Lyon Streets (2400 block).

11 **TWO-HOUR PARKING TIME LIMIT, 9 AM - 6 PM, MONDAY THROUGH SATURDAY -**
12 **ESTABLISH**

13 DeHaro Street, both sides, between 15th and 17th Streets.

14 **TOW-AWAY, NO STOPPING, 3 PM TO 6 PM, MONDAY THROUGH FRIDAY - RESCIND**
15 **TOW-AWAY, NO STOPPING, 4 PM TO 6 PM, MONDAY THROUGH FRIDAY - ESTABLISH**

16 Sutter Street, north side, between Sansome and Montgomery Streets; and,

17 Sutter Street, both sides, between Montgomery and Kearny Streets

18 **TOW AWAY, NO STOPPING, 7 AM TO 9 AM AND 4 PM TO 7 PM, MONDAY THROUGH**

24 Davis Street, west side, between Sacramento and California Streets.

1 South Van Ness Avenue, west side, from 13th Street to 19th Street

2 **NO PARKING ANYTIME - ESTABLISH**

3 Marin Street, north side, between 3rd and Illinois Streets.

5 1(c)(9) changes in the traffic and parking regulations
6 where such changes do not establish a higher speed
7 limit or result in more than a negligible increase in the
