3 **Resolution authorizing the San Francisco Department of Public Health (SFDPH) to**
4 **submit an interim progress report (IPR) in order to continue to receive funding for the**
5 **HIV Prevention Projects grant from the Centers of Disease Control and Prevention**
6 **(CDC). This amount of this annual recurring grant for the next grant year (January 1,**
7 **2007 to December 31, 2007) is expected to be approximately \$9 million. The due date of**
8 **the IPR is September 15, 2006.**

10 WHEREAS, The San Francisco Board of Supervisors passed Ordinance No. 265-05 in
11 November 2005, amending Section 10-170 of the Administrative Code to require Board
12 review of proposed annual or otherwise recurring grant applications of \$5,000,000 or more
13 prior to their submission; and,

14 WHEREAS, SFDPH is currently a recipient of the HIV Prevention Programs grant in
15 the amount of \$9,019,618 from the CDC; and,

16 WHEREAS, SFDPH uses these funds to cover a multitude of HIV prevention programs
17 for San Francisco residents, with 35 percent of the total award amount used for administrative
18 costs (including planning, evaluation, coordination of programs, and contract management)
19 and the remaining 65 percent is subcontracted to qualified contractors selected through RFP
20 to provide direct services to clients; and,

21 WHEREAS, Ordinance No. 265-05 requires that City Departments submit applications
22 for approval at least 60 days prior to the grant deadline for review and approval; and,

23 WHEREAS, While the CDC released the application announcement on July 11, with a
24 due date of September 15 allowing just 66 days for the entire process; and,


