10 District of San Francisco known as "South Sunset Playground"; and,

11 WHEREAS, The children's play equipment was recently vandalized by arsonists; and

12 WHEREAS, A local group of park advocates banded together to form the South Sunset
13 Playground Campaign; and

14 WHEREAS, The Campaign raised funds from various neighbors and local business'
15 and organizations; and

16 WHEREAS, The Campaign hired the Neighborhood Parks Council as their 501-c3
17 fiscal agent; and

18 WHEREAS, The monetary gift will be used for labor and materials for the new play
19 equipment and lighting project at South Sunset Playground; and,

20 WHEREAS, The improvement work will be completed to the standards established by
21 the Recreation and Park Department and governing codes; and,

22 WHEREAS, Through Recreation and Park Commission resolution number 0606-009
23 the Commission recommends to the Board of Supervisors to accept and expend the monetary


