3 **Resolution authorizing the Mayor's Office of Criminal Justice (MOCJ) to accept and**
4 **expend a grant in the amount of \$158,000 from the Project Safe Neighborhoods (PSN),**
5 **Department of Justice (DOJ), Bureau of Justice Assistance (BJA), for the purpose of**
6 **supporting activities to reduce the gun crime problem and violent activity associated**
7 **with gun crime in San Francisco.**

8 WHEREAS, MOCJ is the lead fiscal agency in administering the Project Safe
9 Neighborhoods Project Gun Stop Program; and

10 WHEREAS, San Francisco applied and was awarded on June 6, 2006, one-hundred
11 fifty-eight thousand dollars (\$158,000); and

12 WHEREAS, The Mayor's Office of Criminal Justice in partnership with the San
13 Francisco Police Department, the San Francisco District Attorney's Office, the San Francisco
14 Adult Probation Department, the San Francisco Juvenile Probation Department, the San
15 Francisco Sheriff's Department, United Playaz and the U.S. Attorney's Office for the Northern
16 District of California will be responsible for coordination and day-to-day operations of the
17 planning and implementation phases of this grant; and

18 WHEREAS, MOCJ will be responsible for the fiscal, programmatic and administrative
19 reporting to BJA; now, therefore, be it

20 **RESOLVED, That the City and County of San Francisco hereby authorizes MOCJ to**
21 **accept and expend \$158,000 from the Bureau of Justice Assistance, to administer the Project**
22 **Gun Stop Program.**


