3 **Resolution approving the assignment of the street flower market permit identified as**

8 WHEREAS, Harry Hoogasian, the Permittee who operated the flower market known as  
9 the Emporium Street Flower Market, located on the south sidewalk of Market Street facing  
10 835 Market, passed away in 2003. Anne Hoogasian, the Permittee's spouse, thereafter  
11 became Permittee of said flower market in accordance with Public Works Code Section  
12 161(l). Recently, Ms. Hoogasian passed away. Jimmy, John, and Ann Hoogasian, living  
13 members of Ms. Hoogasian's family as stipulated in Article 5, Section 161(l) of the Public  
14 Works Code, request permission to allow the assignment of said permit to them as co-  
15 permittees. A copy of said request is on file with the Clerk of the Board of Supervisors in File  
16 No. 061202 and is incorporated herein by reference; and,

17 WHEREAS, The assignee(s) shall comply with all and regulations governing Street  
18 Flower Markets, including Article 5 of the Public Works Code and DPW Order No. 175,880. A  
19 copy of said Order is on file with the Clerk of the Board of Supervisors in File No.  
20 061202 and is incorporated herein by reference; now, therefore, be it,

21 RESOLVED, That the Board of Supervisors hereby authorizes the assignment of said  
22 permit.




