7 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
8 does hereby appoint the hereinafter designated persons to serve as members of the
9 Immigrant Rights Commission, pursuant to the provisions of Ordinance No. 211-97, for the
10 terms specified:

11 Solomon Jones, succeeding himself, term expired, seat 3, must have a demonstrated
12 knowledge of and interest in the health, human service, educational, or employment issues
13 that affect immigrants residing in San Francisco, for the unexpired portion of a two-year term
14 ending June 6, 2008.

15 Angus McCarthy, succeeding Svetlana Kaff, seat 7, resigned, must be an immigrant to
16 the United States who is appointed in accordance with Section 4.101 of the Charter. In
17 addition, members shall have a demonstrated knowledge of and interest in the health, human
18 service, educational, or employment issues that affect immigrants residing in San Francisco,
19 for the unexpired portion of a two-year term ending June 6, 2007.

20 Elahe Enssani, succeeding herself, term expired, seat 9, must be an immigrant to the
21 United States who is appointed in accordance with Section 4.101 of the Charter. In addition,
22 members shall have a demonstrated knowledge of and interest in the health, human service,
23 educational, or employment issues that affect immigrants residing in San Francisco, for the
24 unexpired portion of a two-year term ending June 6, 2008.


