8 WHEREAS, the people of the State of California have enacted the California Oil
9 Recycling Enhancement Act that provides funds to cities and counties for establishing and
10 maintaining local used oil collection programs that encourage appropriate disposal and
11 recycling of used oil; and,

12 WHEREAS, the California Integrated Waste Management Board (CIWMB) has been
13 delegated the responsibility for the administration of the program within the state, setting up
14 necessary procedures governing application by cities and counties under the program; and,

15 WHEREAS, after a competitive process, the CIWMB has selected the City and County
16 of San Francisco to receive a grant in this area; and

17 WHEREAS, the City and County of San Francisco will enter into agreement with the
18 State of California for implementation of used oil and oil filter collection and public outreach
19 programs in marinas serving the residents of the City and County of San Francisco; and,

20 WHEREAS, the grant budget includes provision for indirect costs of \$6,215.00 in the
21 grant budget; now, therefore, be it


22 RESOLVED, that the Director of the Department of the Environment, or a designee, is


