

1 [Increasing the distribution of uniform filing fees to the Law Library provided by the Business
2 and Professions code.]

4 **Resolution increasing the distribution of uniform filing fees provided by Business and**
5 **Professions Code sections 6321 and 6322.1 to defray Law Library expenses.**

6 WHEREAS, Pursuant to the enactment of the Uniform Civil Fees and Standard Fee
7 Schedule Act of 2005 (UCF Act), a uniform schedule of civil court filing fees was established
8 for California superior courts; and
9

10 WHEREAS, The Administrative Office of the Courts assumed centralized control of
11 the collection and distribution of filing fees, including the Law Library's portion, and makes
12 monthly distributions from uniform court filing fees to the Law Library fund pursuant to
13 Business and Professions code section 6321; and,

14 WHEREAS, This Board of Supervisors has determined that a \$3.00 increase in the
15 distribution to the Law Library is necessary to defray the expense of the Law Library as
16 provided by California Business and Professions Code section 6322.1(a); and,

17 WHEREAS, Under the UCF an increase in the Law Library distribution does not
18 change or increase the amount of San Francisco's civil court filing fees; and,

19 WHEREAS, The \$3.00 increase in the distribution of fees to the Law Library will
20 provide funds for the benefit of the people of San Francisco that the Law Library would not
21 otherwise have; now, therefore, be it

1 RESOLVED, That the amount of the filing fee distributed to the San Francisco Law
2 Library from the uniform fees referenced in California Business and Professions Code section
3 6322 be increased by \$3.00 to \$42.00, effective January 1, 2007; and, be it

4 FURTHER RESOLVED, That a copy of this resolution be forwarded to his honor, the
5 Mayor, with a request that he transmit copies to the California Administrative Office of the
6 Courts, and to the Superior Court of the City and County of San Francisco no later than
7 December 14, 2006.




