3 **Resolution accepting a gift of equipment to the Fire Department from the Fireman's**  
4 **Fund Insurance Company as follows: (1) an ambulance simulator and a training**  
5 **mannequin, with a combined value of approximately \$37,200; and (2) equipment for the**  
6 **Fire Boat valued at approximately \$10,000.**

8 WHEREAS, The Fireman's Fund Insurance Company was founded in San Francisco in  
9 1863 with a mission to give a portion of its profits to support firefighters; and,

10 WHEREAS, The Fireman's Fund Insurance Company has established the Fireman's  
11 Fund Heritage program to support the company's philanthropic mission to support firefighters  
12 for safer communities; and

13 WHEREAS, Through the Heritage program, Fireman's Fund provides local fire  
14 departments, national firefighter organizations, and non-profit fire and burn prevention  
15 organizations with equipment and fire prevention tools, or funds for equipment, tools,  
16 firefighter training, fire safety education and community emergency response programs; and,

17 WHEREAS, Fireman's Fund employees can nominated their local fire department to  
18 receive a grant or gift through the Heritage programs; and,

19 WHEREAS, an agency that sell Fireman's Fund products can direct a grant or gift to a  
20 local fire department, based on the size and growth of the agency's business with Fireman's  
21 Fund; and,

22 WHEREAS, two local insurance agencies have separately selected the Fire  
23 Department to receive a gift on behalf of that agency through the Fireman's Fund Heritage

1           WHEREAS, Accordia, Inc., an insurance agency in San Francisco, wishes to direct a  
2 gift to the Fire Department through the Heritage program to support emergency medical  
3 services across the City, and has offered to provide the Fire Department with a gift of an  
4 ambulance simulator, including delivery and set up of the simulator, and a training mannequin  
5 to be used for Paramedic and Emergency Medical Technician training, with a combined value  
6 of approximately \$37,200; and,

7           WHEREAS, SP Tarantino Insurance Brokers, Inc., an insurance agency in San  
8 Francisco, wishes to direct a gift to the Fire Department through the Heritage program to  
9 support the Fire Boat, and has offered to provide the Fire Department with a gift of marine  
10 electronic equipment including delivery and installation of that equipment, valued at  
11 approximately \$10,000; and,

12           WHEREAS, Fireman's Fund Insurance Company, through its Heritage program,  
13 wishes to provide the gifts as designated by these local agencies; and,

14           WHEREAS, these gifts will benefit the Fire Department and facilitate its safe and  
15 effective delivery of services to the public;

16           WHEREAS, A Gift Agreement between the Fire Department and Fireman's Fund  
17 Insurance Company is on file with the Clerk of the Board of Supervisors in File  
18 No. 061290, which is hereby declared to be a part of this resolution as if set  
19 forth fully herein; now, therefore, be it

20           RESOLVED, That the Fire Department is authorized to enter into the Gift Agreement  
21 with Fireman's Fund Insurance Company; and, be it

22           FURTHER RESOLVED, That the Chief of the Fire Department is authorized to accept  
23 gifts from Fireman's Fund Insurance Company of (1) an ambulance simulator, including  
24 delivery and set up of the simulator, and a training mannequin to be used for Paramedic and


1 Emergency Medical Technician training, with a combined value of approximately \$37,200; and  
2 (2) a gift for the Fire Boat of marine electronic equipment, including installation of that  
3 equipment, valued at approximately \$10,000; and, be it

5 requirements and conditions specified in the Gift Agreement.




