3 **Resolution determining that the transfer of a Type 20 off-sale beer and wine**
4 **license from 55 Beverly Street to 1455 Custer Avenue to Kathryn E. Kaufer for**
5 **Kaufer's Religious Supplies will serve the public convenience and necessity of**
6 **the people of the City and County of San Francisco, in accordance with Section**
7 **23958.4 of the California Business and Professions Code, with conditions.**

9 WHEREAS, Kathryn E. Kaufer is seeking transfer of a Type 20 off-sale beer and
10 wine license for Kaufer's Religious Supplies located at 1455 Custer Avenue; and,

11 WHEREAS, The City Planning Department has verified that the area is properly
12 zoned; and,

13 WHEREAS, The Police Department recommends that the liquor license
14 application be approved with conditions; now, therefore, be it

15 RESOLVED, That in accordance with Section 23958.4 of the California Business
16 and Professions Code, the Board of Supervisors of the City and County of San
17 Francisco hereby determines for the foregoing reasons that the transfer of a Type 20
18 off-sale beer and wine license from 55 Beverly Street to 1455 Custer Avenue for
19 Kathryn E. Kaufer for Kaufer's Religious Supplies, will serve the public convenience and
20 necessity of the people of the City and County of San Francisco.

21 Conditions: (1) Petitioner(s) shall not permit their patrons or the general public to
22 loiter or congregate on the sidewalks adjacent to the licensed premises. Patrons
23 standing in line to enter the premises shall not be considered loitering or unlawfully
24 gathering. (2) The petitioner(s) shall be responsible for maintaining free of litter the area
25 adjacent to the premises over which they have control. (3) Sale and service of alcoholic

1 beverages shall be allowed between the hours of 8:00 a.m. and 6:00 p.m. each day of
2 the week. (4) The sales of alcoholic beverages shall be restricted to the sale of wine
3 only. At no time shall beer and/or malt products be on the premises.




